This system put in place by CAF will allow the continuity of rights for those who need it. serious term of "We are at war (Sanitary)" [Updated on Thursday March 19 at 9:35 pm] The following are particularly concerned: active solidarity income (RSA), solidarity income (RSO) in overseas countries, the disabled adult allowance (AAH), the disabled child education allowance (AEEH), and all of the social assistance paid under means test by CAF. Housing aid will be automatically maintained. In addition, the rights to the disabled adult allowance (AAH) and the disabled child education allowance (AEEH) which expire will be automatically extended by six months. In the same way, the rights to complementary health insurance and assistance with the payment of additional health insurance, the benefit of which will expire in the coming months, will be extended by 3 months. These provisions will be passed as part of the Emergency Bill presented to Parliament this week. The ministers would like to thank all the CAF agents, the primary health insurance funds and the agricultural social mutual funds which, despite a difficult context, ensure continued support for the most vulnerable French people.
